Subject:-Minutes of the meeting taken by Joint Secretary (Development) in his chamber on 09/05/2017 at 3.30 PM with representatives from SGFI & AIU to discuss the modalities for holding National Level Khelo India Competitions in collaboration with SGFI and AIU.

- 1. Joint Secretary (Development) chaired the meeting.
- 2. List of participants is annexed.
- 3. At the outset, Joint Secretary (Development) welcomed the participants and apprised them of the proposed revision of the Khelo India Scheme and the decision to hold National Level School Games and National Level University Games under the revised Scheme in collaboration with the SGFI and AIU respectively. He indicated the intent to hold the Khelo India National Level School Competitions 2017-18 in Delhi, in collaboration with SGFI, for which detailed modalities, including calendar, logistics, technical support, disciplines, venues, registration, transport, expected participation, boarding and lodging of participants and officials, prize money, medals, certificates, period/duration of the games, head wise fund requirement, talent search by experts, details of opening/closing ceremonies and age limit, media coverage, security, medical, organising committees, (working committee, finance committee, Governing Body etc.) are required to be finalized/formed. Similar action is also to be taken for the Khelo India National Level University Competitions 2017-18.
 - 4. The matter was deliberated upon and based upon the deliberations, the following were agreed to:
 - i. Representatives of both SGFI and AIU welcomed the proposal for holding National Level School and University Competitions jointly with the Government.
 - ii. It was decided to hold the competitions during the months of December and January.
 - iii. Both SGFI and AIU agreed to work out modalities and detailed proposal for the proposed competitions within two weeks after discussion with various stake holders.
 - iv. SGFI agreed to prepare draft prospectus and discipline wise leaflets for the 2017-18 competitions.
 - v. It was agreed that the details may be worked out after taking into account other events lined up during December-January during this year that may clash with the National Level Competitions.
 - vi. Both SGFI and AIU agreed to suggest names for various committees to be set up for effective delivery of the competitions. It was decided that representatives of all participating NSFs would be members of the GTCC.
 - 3. It was also agreed to convene a meeting under the Chairmanship of Secretary (Sports) with relevant Sports Federations, for seeking their technical and all other necessary support required for smooth conduct of the games.
 - 4. The meeting ended with vote of thanks to the chair.
